



# 2026 CIRCLE BROOK FARM CSA PROGRAM PRICING

We will again offer a 24-week farm share program for the 2026 season.

We anticipate deliveries will begin during the week of June 8<sup>th</sup>.

The final delivery will be during the week of November 16<sup>th</sup>.

A slight increase in share prices, consistent with the average inflation rate, is necessary to maintain already slim margins and keep the farm profitable. I believe that the CSA program will continue to provide excellent value.

## **Premium share-** \$1125

Share will contain, on average, 10-12 items and a larger quantity of many of the items in the basic share. Over the course of the season the premium share will include various less common vegetables, such as escarole, radicchio, fennel and frisée, not found in the basic or half share.

## **Basic share-** \$925 =

Share will contain, on average, 9-10 items. It will be approximately 80% the size of the Premium share.

## **Pre-bagged half share-** \$740

Share will contain, on average, 9-10 items and half of the quantity of many of the items in the premium share. The share will be approximately 60% the size of the Premium share.

The share price includes the cost of bagging.

**Early Bird Discount (EBD)-** We offer an advance payment discount on all share sizes if paid in full by March 1<sup>st</sup>. The amount of the discount will be based on the share size, as noted above. This deadline will be strictly adhered to, please do not ask me to extend it.

**Pre-bagged Basic and Premium shares-** We would prefer not to pre-pack the larger shares but will do so if necessary. Please do not promote this service. Pre-bagged shares will incur an upcharge of \$80 for either share size.

### Egg Share

#### Weekly · 24 weeks

Free-range birds on pasture for 8 months of the year. Not certified organic; feed contains soy.

- 1 dozen/week – **\$150**
  - 2 dozen/week – **\$275**
  - 3 dozen/week – **\$395**
  - 4 dozen/week – **\$505**

### Fruit Share

#### 12 weeks (not consecutive) · \$220

Two types of fruit weekly, averaging **5–7 lbs.**

Fruit is locally sourced whenever possible. Some local fruit may be organic; most is **eco-grown** (organic methods used, when possible, with limited early-season spraying). Eco-grown fruit is monitored and tested for pesticide residue. If local crops fail, organic fruit will be sourced from CA or WA.

**Possible selections:** blueberries, cherries, plums, peaches, nectarines, pluots, hardy kiwi, apples, pears (availability varies).

Higher-value fruits may result in lower total weight. A **large watermelon** will be included.

The final 5–6 weeks will feature mostly apples and pears.

### Mushroom Share

#### Weekly · 24 weeks · \$240

Provided by **Inoculated LLC (Joe Aochoa)** of Fairfield, NJ. Certified organic exotic mushrooms.

- Weekly **½-lb box**
  - Varieties may include: Blue, Green, or Yellow Oysters, Lion's Mane, Black Trumpets, and Shiitakes

### Flower Share

#### 10 weeks · \$100

Bouquets are typically sold at farmers' markets for **\$12–15 each.**

Runs July–October. Shares are delivered as availability allows (some consecutive weeks, some breaks).

**Varieties include** snapdragons, lisianthus, sunflowers, zinnias, cosmos, celosias, and mixed seasonal bouquets.

I commit to membership in the Spring Lake Heights, CSA for the 2025 season which is planned to run for 24 weeks starting Friday, 6/8/26 and ending 11/16/26.

As a member of the CSA, I will receive a weekly share of produce. The shares will vary by size and weight depending on the season. One aspect of CSA is that members support their farmers by sharing in the inherent risks of agriculture (poor weather, drought, disease, early frost, crop failure and so on) and rewards (the bounty from a good season.) CSA farmers purposely plan for such contingencies and use growing techniques that protect the harvest, minimize risk to members and optimize the rewards: growing a wide variety of crops that thrive in different types of conditions, cover cropping, crop rotation, and irrigation. Moreover, the CSA builds relationships of trust between the farmer and the community group. Overall, members should get a wide variety of vegetables in generous amounts. Therefore, I agree that while John Krueger will act in good faith to provide fresh organic produce for the duration of the season, there is no guarantee of quantities or contents of weekly shares.

I am fully aware that it is necessary to inspect and wash all produce thoroughly before consuming. John, his workers, his farm, all CSA members and administrators, Marianne Wagner and Colleen Orozco, and the settings we use to pick up our shares and their administrators and employees have no liability in terms of the safety of the food or the premises.

I am also fully aware that when driving, parking, and picking up my CSA share at the O'Sullivan residence of 1291 Surrey Lane, Spring Lake Heights, NJ, I do so willingly, and the homeowners have no liability.
